### WARRANTY PERIOD:

Your new ProTurf® Green / Blue / Black Turf and Irrigation Pipe is warranted by Centennial Plastics Inc. to you, the original purchaser, for as long as you own the property in which the ProTurf® Green / Blue / Black Irrigation Pipe has been installed.

### WHAT IS COVERED:

If your ProTurf® Green / Blue / Black Turf and Irrigation Pipe fails due to proven defects in material and workmanship, Centennial Plastics Inc. will install new, warranted pipe in your property. You will not be charged for the pipe, the freight or the labor required to install it.

This lifetime Warranty is not applicable in the event of installation and/or use of the pipe which is not in accordance with specifications, and is not applicable with respect to any failure performance of the pipe which is due in whole or part to any reason other than a defect in the material or workmanship of the pipe.
