

1 Year Warranty

Centennial Plastics Inc. warrants to the original retail purchaser that in the event CenFlex (“the pipe”) fails to perform in accordance with its specifications due to a defect in the materials or workmanship of “the pipe” within one (1) year from the date of the original retail purchase of “the pipe” Centennial Plastics Inc. will provide to the holder of the Limited Warranty pipe of equivalent or better quality or repair “the pipe”

THIS LIMITED WARRANTY IS THE EXPRESS WARRANTY RELATING TO THE PIPE. THE LIMITED WARRANTY IS THE ONLY WARRANTY ISSUED BY CENTENNIAL PLASTICS INC. FOR THE PIPE AND IS ISSUED IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

The limited Warranty is not applicable in the event of installation and/or use of “the pipe” by the holder of the Limited Warranty or any third party which is not in accordance with the specifications for installation and use of “the pipe”, and is not applicable with respect to any failure in performance of “the pipe” which is due in whole or in part to any reason other than a defect in the materials or workmanship of the “the pipe”.

If the “the pipe” fails to perform in accordance with its specifications due to a defect in the materials or workmanship of “the pipe” within one (1) year from the date of original retail purchase of “the pipe”, the holder of the Limited Warranty shall submit to Centennial Plastics Inc. written notice of the defect and a clearly identifiable sample of the defective pipe within thirty (30) days after the defect becomes or should become known to the holder.
